

DECISION OF THE GOVERNOR OF WEST JAVA NUMBER: 561 / Kep.1486-Bangsos / 2016 CONCERNING DISTRICT/CITY SECTOR MINIMUM WAGES IN WEST JAVA PROVINCE FOR 2017

GOVERNOR OF WEST JAVA

Considering:

a. that the District/ City minimum wages of West Java Province in 2017, has been established by decision of the governor of West Java No. 561 / Kep.1191-Bangsos / 2016;

b. that under the provisions of Article 89 paragraph (1) letter b and paragraph (3) of Law No. 13 of 2003 on Labour in conjunction with Article 49 paragraph (1) and (2) of Government Regulation No. 78 of 2015 on Wage, District/ City Minimum Wages to be determined by the Governor based on an agreement with the employers' association of trade unions in the sectors concerned, and after getting advice and considerations over the leading sectors of Provincial and District Wage Council or the Council in accordance with the duties and authorities;

c. that based on the results of the discussion, the examination and assessment by Wage Council of West Java province contained in the Letter of Recommendation No. 561/22 / XII / Depeprov / 2016 Date December 22, 2016, it has recommended District/City sector minimum wage in 2017 for 6 (six) Districts / Cities in West Java Province;

d. Based on the said considerations mentioned in letters b and c, it is necessary to set out a West Java Governor Decision on District/City Sector Minimum Wage in West Java Province for 2017;

- 3. Minutes of the meeting between an international restaurant management company with representatives of PHRI

Sukabumi city in order to propose the MSE Sector Consultative Restaurant International scale in the city of Sukabumi, on 10 November 2016 and Minutes of Agreement between the Indonesian Retailers Association (APRINDO) Sukabumi Chapter and Branch of Trade Unions of Sukabumi, dated 23 November 2016;

- 4. Minutes of Talks between the Employers' Association of bottled water sector with the Multi-National Union of Packaged Beverage Multi National District Sectoral Minimum Wage Fixing Cianjur 2017 National Multi drinking water sector, dated 15 November 2016;
- 5. The minutes of negotiations discussion Sector minimum wages for Packaged Beverage & Food Beverage Tobacco sector between Trade Unions (PC SP RTMM SPSI and DPC GSBI) and the Employers' Association (APINDO) Sukabumi Chapter (Date December 15, 2016);
- 6. Minutes of Negotiation between the Indonesian Employers Association (APINDO) Depok City Sectoral Minimum Wage Fixing for 2017, month of November 2016;
- 7. Minutes of the Negotiation between the employers / APINDO and different trade unions members District Wage Council of Bogor on Sectoral Minimum Wage for Bogor District 2017, dated 22 November 2016;

DECIDE:

to enact:

ONE

: Amounts of District/Sector Minimum Wages in West Java Province in 2017 as contained in the annex, as an integral part of this Decision.

TWO

: The District/City Sector minimum wage in West Java Province for 2017 as mentioned in

the Dictum ONE, should not be lower than the District/City minimum wage in West Java Province for 2017.

THREE

: Oversight and control over the implementation of the District/City Sector Minimum Wages District in the province of West Java for 2017 as mentioned in the Dictum ONE, carried out by the Governor of West Java and Regent of Indramayu, Mayor of Sukabumi, regent of Cianjur, Regent of Sukabumi, Mayor of Depok, and Regent of Bogor in accordance with their respective authorities, under the statutory provisions.

FOUR

: This decision shall come into force on January 1, 2017.
