# PROVINCIAL SECTORAL MINIMUM WAGE YEAR 2018

# BY THE GRACE OF GOD ALMIGHTY

# THE GOVERNOR OF CAPITAL SPECIAL REGION OF JAKARTA.

- Considering: a. whereas pursuant to the provision of Article 49 of the Government Regulation Number 78 of 2015 concerning Wage and considering the bargaining agreements of the employer association and trade unions, the Governer is authorized to set the Povincial Sectoral Minimum Wage;
  - b. whereas based on the considerations as referred to in letter a, it is necessary to stipulate the Governor Regulation concerning Provincial Sectoral Minimum Wage Year 2018;
- In view of : 1. Law Number 21 of 2000 concerning Trade/Labour Union;
  - 2. Law Number 13 of 2003 concerning Manpower;
  - 3. Law Number 29 of 2007 concerning Provincial Government of the Capital Special Region of Jakarta as the Capital of the Unitary State of the Republic of Indonesia;
  - 4. Law Number 12 of 2011 concerning the Establishment of Laws and Regulations;
  - 5. Law Number 23 of 2014 concerning Local Government as amended several times, the latest of which by Law Number 9 of 2015;
  - 6. Government Regulation Number 78 of 2015 concerning Wages;
  - 7. Presidential Decree Number 107 of 2004 concerning Wage Council;
  - 8. Minister of Manpower and Transmigration Decree Number KEP-201/MEN/2001 concerning the Representativeness in the Industrial Relation Institutions;

- 9. Minister of Manpower and Transmigration Regulation Number 7 of 2013 concerning Minimum Wages;
- 10. Provincial Regulation Number 6 of 2004 concerning Manpower;
- 11. Provincial Regulation Number 5 of 2016 concerning the Establishment and Organization of Provincial Agencies of the Capital Special Region of Jakarta;
- 12. Governor Regulation Number 59 of 2005 concerning Organization and Work Procedure of Wage Council of the Capital Special Region of Jakarta;
- 13. Governor Regulation Number 271 of 2016 concerning Organization and Work Procedure of Manpower and Transmigration Office;
- 14. Governer Regulation Number 182 of 2017 concerning Provincial Minimum Wage Year 2018;

# HAS DECIDED

To stipulate: GOVERNOR REGULATION CONCERNING PROVINCIAL SECTORAL MINIMUM WAGE YEAR 2018.

# Article 1

- (1) Provincial Sectoral Minimum Wage (PSMW) Year 2018 is set in the following sectors or sub-sectors:
  - a. chemical, energy and mining;
  - b. metal, electronics and machines;
  - c. automotive:
  - d. insurance and banking;
  - e. foods and beverages
  - f. pharmaceutical and health;
  - g. textile, garment and leather;
  - h. tourism:
  - i. telecommunication;
  - j. retail; and
  - k. building and general construction;
- (2) Rates of the Provincial Sectoral Minimum Wage (PSMW) as referred to in paragraph (1) are included in the Appendix to this Governer Regulation.

#### Article 2

Employers who belong to the established categories as referred to in Article 1 shall be prohibited to pay lower than the Provincial Sectoral Minimum Wage (PMW) Year 2018.

Article 3

Provincial Sectoral Minimum Wage (PSMW) Year 2018 as referred to in Article 1 is applicable only to workers/labourers with less than 1 (one) year of service.

#### Article 4

Review of the rate for workers/labourers with more than 1 (one) year of service is conducted based on a written agreement achieved through a bipartite bargaining between workers/labourers and/or trade/labour union(s) and the employer in the enterprise.

# Article 5

This Governor Regulation shall come into force at the date of its enactment and is retroactive commencing from 1 January 2018.

For public cognizance, ordering the promulgation of this Governor Regulation by placing it in the Provincial Gazette of the Capital Special Region of Jakarta.
