#### CONCERNING

## BANTEN PROVINCIAL MINIMUM WAGE YEAR 2019

#### THE GOVERNOR OF BANTEN,

- Considering: a. whereas in an effort to motivate workers' participation in the enterprises' productivity and advance, a policy measure is needed in order to improve workers' welfare by providing them with decent earnings, by taking factors of local condition and enterprises' ability into account and referring to the fulfillment of decent living needs;
  - b. whereas based on the consideration as referred to in letter a, it is necessary to stipulate the Governor Decree concerning Banten Provincial Minimum Wage Setting Year 2019;

To stipulate:

FIRST Setting the Banten Provincial Minimum Wage Year 2019 at IDR

2,267,990.546.

SECOND Banten Provincial Minimum Wage rate as referred to in the FIRST

dictum is set based on the following calculation:

2019MW = 2018MW + (2018MW x national inflation + national GDP)

 $= 2,099,385.778 + (2,099,385.778 \times 2.88\% + 5.15\%)$ 

 $= 2,099,385.778 + (2,099,385.778 \times 8.03\%)$ 

= 2,099,385.778 + 168,604.76797

= 2,267,990.546

THIRD This Decree shall come into force at 1 January 2019.
